#### Q: Who is Action4Canada?

A: We are a not-for-profit organization committed to educating, encouraging and equipping Canadians to take action towards protecting our rights and freedoms.

### Q: Why are they commencing legal action?

A: Action<sup>4</sup>Canada is commencing legal action in response to the emergency measures that were taken without having legitimate grounds to do so. The passing of Bill 19 was unlawful and in violation of almost every section of the Charter.

#### Q: What is Bill 19?

A: In July 2020, the BC government rushed passing of Bill 19 without public debate or input. It removes the voters' and their MLA representatives' ability to question/debate or for public consultation. It clearly violates nearly all sections your inherent civil rights as guaranteed under the Charter of Rights and Freedoms Act 1982.

The Bill gives the Lieutenant Governor, a federally appointed individual, almost unlimited power. Debate in the legislature is removed, giving all decision making to the government and the Lieutenant Governor. It removes the opportunity for voters to file lawsuits against these destructive policy measures. This is in direct violation of Sections 91 and 92 of the Constitution Act, 1897. It is legalizing tyranny, without liability

### Q: When we donate, where does our money go?

A: 100% of the funds raised are designated to the legal action. The money is held in a trust account.

# 1. When it comes to businesses who say they are "grateful" to the government because many are receiving rent subsidies and/or monies to pay their staff?

### Suggested Responses:

- The people dying alone with no one at their side?
- Our children and young people who are being abused and traumatized?
- Their health is being put at risk as they are forced to wear a mask cutting off their much-needed oxygen for their brain development and overall well-being.
- Their mental health is at risk as they are being told that they will be responsible for their parents or grandparent's deaths if they don't wear a mask. THIS IS CRUEL AND AN OUTRIGHT LIE.
- It is very well known that children and youth are at a very low risk of getting CoVid and they do not carry the virus and spread it to others.
- A symptomatic people do not spread the virus so why are our children being forced to wear masks and social distance?

### 3. What about:

- The people wherein life-saving surgeries and treatments were deemed nonessential?
