Do you have any of those documents in French? I need them for my children's teachers in Quebec

A script when you serve a notice liability would be helpful for sports organizations, employers, schools, etc.

As we are educating ourselves. It would be great to have a How-to section on Action 4 Canada website with tutorials on actions we should exercise. With examples on how to apply the notice of liabilities with the main scenarios, we are facing, for example:

- Wearing masks
- Denied entry if not Vaxx
- Enforced Vaccination

Maybe you can do a clear youtube video or something of how to serve a Notice of Liability? to ask questions and know how to handle the current situation with confidence.

Get your appropriate NOL's in your Hand then get together as a group and practice practice practice for 1 week - then serve the NOL by Registered Mail and keep a copy handy in your pocket and talk with your knowledge - take a breathe and talk it practice with each other.

Is taking a video while serving NOL A MUST? What if they say i am violating their rights by taking video?

What if you use a notice and they still fire you?

How will the NOL be utilized?

What does that NOL do in the long term?

Can we send the Notice of Liability through Email ?

I went to Jury Duty in Toronto today. I was removed when asked my vaccine status. I would not disclose and was asked to leave. I argued and told them it was unlawful. I was told to leave as I did not have the right to be there if I am not vaccinated. Should I go to the HRTO?

I was told that the charter only applies to the federal government. is this true?

Any advice on how students who did not submit to the unlawful univ mandates should handle themselves in campus? If serving the NOL they would expose themselves, therefore could face peer pressure.

Can I give the liability form to employer even if I'm not in a union?

Do union lawyers have to represent you under a union or can you get outside lawyer to represent you personally??

When will you have a Notice of Liability to Unions that refuse to represent employees who do not wish to get vaccinated?

The same notice of liability that you give your employer can be given to the union as well.

Family YMCA won't allow me to enter the building to take my son to swimming lessons unless I am vaccinated. Is there something I can send them?

I have just been refused to go to my school campus to take "In person" courses unless I am vaccinated. What can I do?

How do we protect ourselves from the people, In stores and restaurants. if we don't comply with masks? can't call the cops for help

What will happen to teachers that do not consent to testing and refuse?

What can we do now to keep our employment? a letter won't help in AHS

What do we do if we lose our jobs and can't pay our mortgage and bills?

Can we make the MP's in this election sign liability papers if they are going to force this? They can't have it both ways! Why can't we threaten them like they are to us! Threaten them with law suits for forcing this!

What do we say if we don't want to wear the mask?


My caretaker has been bullying me to wear a mask. Is there a letter I can send to the Management company?

Ontario Hockey League is requesting Fans to be double-vaccinated starting in October and the Arenas have an electronic questionnaire for fans to fill out before entering and the 1st question is are you vaccinated? What laws are they violating so I can challenge them?

When asked with proof of vaccine, do we present notice of liability or accommodation with exemption? This Question is for teachers and students... What if they expel the student?

What actions can be taken for Self Employed who are Event Planners and Arts Producers?

We'll be attending to a conference on Sept 14 and we've been told that we not allow to attend until we get vaccines. Can I issue them the notice of liability?

What can be done for students in universities that mandated to have ? They are not allowed on campus until they fully vaxxed.am in Manitoba.

My daughter was told by Cambrian college that she will be charged with trespass, if she tries to enter the property, residence, classes. After sending NOL.

I filed a Human Rights complaint against a Chapters/Indigo branch in November of 2020. I was sent a copy of a "response" by a lawyer for Chapters in January of 2021 and have heard NOTHING from the Human Rights Commission since. Not sure how effective filing these complaints are given my experience.

My ... works in camp in Kitimat and everyone is being told that by October sometime that vaccines will be mandatory to fly, stay in camp and to even work on site. He has the form but to get all the non people together is pretty much impossible. What legally can he do?

What if you are prevented from entering your workplace because you don't have proof of vaccination?

Do I need 1 of these vaccine notice of liability form 4 each business asking me to show proof of vaxx or NO entry & what do I fill out at the top ?

In Toronto- the Toronto Catholic Board is saying the OHSa supersedes the Charter of Rights and Freedoms - and all other laws that protect privacy, Covid testing and vaccination status.

Does OHSa supersede the Charter or any other law we are using to protect us from disclosure, testing and vaccinations?

What if your employer has made a policy stating that if you do not comply, disciplinary actions will be taken? Also to any new hires will have to show proof of Vax within 45 days or they will be terminated.

My husband and I own a business here in the Ottawa area. We have never and never will wear masks in our shop. Have never required our employees or customers to wear one either.

I have never worn a mask, when asked I say I have an exemption, when challenged I threaten to serve them for discriminating against me, they have always let me shop without a mask

I have not worn a mask since this started. I say I am exempt. I have had no problems. I have quoted the charter of rights when needed. Also the Privacy Act

They are not able to do anything when you don't wear a mask. They ask about the mask, but they cannot enforce the wearing of the mask. I have passed police and security guards without a mask indoor and in the subway.

I've gone shopping several times with out a mask. I just carry on like I'm doing nothing wrong, because I'm NOT

All of these medical interventions require explicit and informed consent under the Health Care (Consent) and Care Facility (Admission) Act

FDA released document titled, "SARS-CoV-2 Reference Panel Comparative Data." Here is a killer quote: "During the early months of the Coronavirus Disease 2019 (COVID-19) pandemic, clinical specimens [of the virus] were not readily available to developers of IVDs [in vitro diagnostics] to detect SARS-CoV-2. Therefore, the FDA authorized IVDs based on available data from contrived samples generated from a range of SARS-CoV-2 material sources (for example, gene specific RNA, synthetic RNA, or whole genome viral RNA) for analytical and clinical performance evaluation. While validation using these contrived specimens provided a measure of confidence in test performance at the beginning of the pandemic, it is not feasible to precisely compare the performance of various tests that used contrived specimens because each test validated performance using samples derived from different gene specific, synthetic, or genomic nucleic acid sources."
