In the **early 2000s** Henry served as part of the [World Health Organization – UNICEF polio eradication](#) programme in [Pakistan](#).^[7] **She continued to work with the World Health Organization in 2001, moving to [Uganda](#) to support their efforts to tackle the [Ebola virus disease](#).**^[8]

Henry helped to establish the [Canada Pandemic Influenza Plan](#), which contains recommendations for health-related activities during the spread of a virus.^[9]

Public Health Measures to Control the Spread of the Severe Acute Respiratory Syndrome during the Outbreak in Toronto

On April 23, 2003, the World Health Organization (WHO) issued an advisory against travel to Toronto.¹¹ Although it was withdrawn six days later, the advisory had a costly effect. The tourism industry lost \$260 million (Canadian), and 11 percent of businesses related to tourism reported layoffs.^{12,13} In

Ontario, provincial government costs of coping with SARS have been estimated at \$1.13 billion (Canadian).¹⁴

Since their launch at Davos in January 2000, one of the major achievements of GAVI and the Global Fund is a new vaccine procurement system. By guaranteeing long-term purchasing commitments, it enables manufacturers to produce vaccines at affordable prices. These vaccines were previously only available for children in industrialized countries. In this way, a viable market has been created combining new and old antigens, such as hepatitis B and DTP. Plans are currently underway to ship vaccines to an additional 15 countries, including Kyrgyzstan, Laos, and eight other countries within Africa, throughout 2001. A total of 74 of the world's poorest countries are expected to receive support from GAVI and the Global Fund.

The Global Fund received an initial \$750 million grant from the Bill & Melinda Gates Foundation and has since received support from governments and other donors. In the future, Global Fund resources may also be used to accelerate the development of vaccines for diseases responsible for significant mortality in developing countries, such as HIV/AIDS, tuberculosis, malaria, and acute respiratory diseases. While the Global Fund has its own board and management for fiduciary and fundraising responsibilities, decisions about programs to receive support are made on the recommendation of GAVI.

The Global Alliance for Vaccines and Immunization (GAVI) is a coalition of organizations formed in 1999 in response to stagnating global immunization rates and widening disparities in vaccine access among industrialized and developing countries. **The GAVI partners include: national governments, the Gates Children's Vaccine Program at PATH, the International Federation of Pharmaceutical Manufacturers Associations (IFPMA), research and public health institutions, the Bill & Melinda Gates Foundation, the Rockefeller Foundation, UNICEF, the World Bank Group and the World Health Organization (WHO).**

The charitable foundation of Microsoft Corp. co-founder Bill Gates pledged \$750 million Monday to vaccinate children throughout the developing world, one of the largest donations ever. The contribution to the international Vaccine Fund will help fight diseases such as diphtheria, whooping cough, measles, **polio** and yellow fever in 72 nations. The funds also will support development of new vaccines for rotavirus, a diarrheal disease that kills 600,000 children annually, and meningitis, a deadly inflammation of the brain and spinal cord.

By itself, Monday's donation from the Bill and Melinda Gates Foundation is among the five largest in history.

Combined with an identical \$750 million Gates gave to establish the fund in 1999, it matches the biggest charitable gift ever -- a \$1.5 billion bequest from the estate of Joan B. Kroc to help the Salvation Army build community centres in the United States.

The World Health Organization credits Gate's first \$750 million with helping to save 670,000 children's lives since 2000.

"We've never made a better investment," Gates said, announcing the vaccine gift.

The Vaccine Fund is the main fund-raiser for the Global Alliance for Vaccines and Immunization, a Geneva-based coalition of governments, United Nations agencies, the World Bank and pharmaceutical makers.

The *Economic Times India* published their report August 2014. They stated that in 2009, tests had been carried out on 16,000 tribal school children in Andhra Pradesh, India, using the human papiloma virus (HPV) vaccine, Gardasil.

This is not the first time that these organizations have been caught illegally testing vaccines in developing countries.

Gates Foundation, WHO, PATH, GAVI, UNICEF Behind Chad Vaccine Disaster

In December 2012, in the small village of Gouro, Chad, Africa, situated on the edge of the Sahara Desert, five hundred children were locked into their school, threatened that if they did not agree to being force-vaccinated with a meningitis A vaccine, they would receive no further education.

These children were vaccinated without their parents' knowledge. This vaccine was an unlicensed product still going through the third and fourth phases of testing.

Within hours, one hundred and six children began to suffer from headaches, vomiting, severe uncontrollable convulsions and paralysis. The children's wait for a doctor began. They had to wait one full week for a doctor to arrive while the team of vaccinators proceeded to vaccinate others in the village.
