Covid-19, Hydroxychloroquine (HCQ) and Public Health advisers Dr. Tam and Dr. Bonnie Henry.

Trudeau and Tam have prohibited hydroxychloroquine from being used as a cure to treat Covid-19. Instead they are pushing for a vaccine. Scientists have been testing coronavirus vaccines for decades and no vaccine has been discovered that does not have "significant risks".

The WHO and those invested in the vaccine are going to great lengths to discredit the use of Hydroxychloroquine. A drug that has been around for over 60 years, FDA approved and deemed a safe drug.

Recently the World Health Organization recommended nearly 4 times the recommended dose of hydroxychloroquine with the intent that it will fail and be disqualified as a safe drug. They knowingly recommended lethal doses according to their own records.

*****The WHO hired a consultant to explore the toxicity of chloroquine in 1979*****

The consultant, H. Weniger, looked at 335 episodes of adult poisoning by chloroquine drugs. Weniger on [page 5](#) notes that a single dose of 1.5-2 grams of chloroquine base "may be fatal."

The recommendation by the WHO to administer high doses came after a failed attempt to discredit the drug through, what turned out to be, fraudulent information from a healthcare analytic firm, Surgisphere, who provided the WHO with data resulting in cancelling hydroxychloroquine clinical trials. Surgisphere reported HCQ dramatically increased the death rate of covid patients. ([Read Here](#)) This was a lie. Surgisphere is reported as a company lacking in medical expertise and hired most of its 11 employees two months prior to releasing the report. As the article states,

"the ulterior motives for the rush to demonize hydroxychloroquine has become clear." Treatments that are not profitable will always be marginalized in favour of costly and frequently less-effective pharmaceuticals."

After this scandal, the WHO was forced to once again commence trials on HCQ.

***As a note...Remdesivir,(a toxic Covid drug) 'touted' by Anthony Fauci...costs \$1,000 per pill, whereas HCQ's generic price is \$0.64."

A vaccine, in comparison, will turn the pharmaceutical industry from a billion dollar business into a trillion dollar business..

Tam and Bonnie Henry both work (worked) for the WHO. They are responsible for protecting Canadians and therefore an investigation should commence into who is responsible for approving the lethal doses of hydroxychloroquine in Canada and who is responsible for withholding the drug as a life-saving treatment which would have saved thousands of lives and would have avoided the need for the lockdown and Emergency Orders.

“**This is an ongoing medical atrocity being perpetrated by medical doctors at [200 sites in 14 countries](#)**: include: Australia, Belgium, **Canada**, Croatia, Germany, Hungary, Ireland, Netherlands, New Zealand, Portugal, Romania, Spain, United Kingdom, and the United States of America.”

“The [registration of the Canadian](#) portion of the Solidarity trial informs us of its HCQ dose: **ten 200 mg tablets during the first 24 hours (800 mg initial dose, 800 mg 12 hours later then 400 mg every 12 hours** for 9 more days). This is 2.0 grams during the first 24 hours, and a cumulative dose of 8.8 grams over 10 days, or only 0.4 grams less than what Recovery used

How is the drug hydroxychloroquine normally used? For chronic daily use in systemic lupus erythematosus, rheumatoid arthritis or Lyme disease, patients receive **between 200 and 400 mg daily**, or a [maximum of 5 mg/kg](#) In acute Q fever, 600 mg daily may be given at the start of treatment. For acute attacks of malaria, [1,500-2,000 mg may be given over 3 days](#) . Professor Didier Raoult's group in Marseille used 600 mg daily for up to ten days in 1061 Covid-19 patients, and [reported 8 deaths, a mortality rate of 0.75%](#) all over 74 years of age. The mortality rate reported by Landray and Horby in the Recovery trial is 34 times higher.

The doses used in these trials are not recommended for therapy of any medical condition, which I confirmed with Goodman and Gilman's Pharmacology textbook, the drug's US label, and the online subscription medical encyclopedia [UptoDate](#).

Excessive, dangerous HCQ dosing continues to be used in WHO's Solidarity trials. While the Solidarity trials have an "adaptive" design which allows midstream protocol changes, no lessons were learned from the Brazil or Recovery trials' experience with excessive dosages. Solidarity has not reduced its HCQ dosing, although it can do so at any time. **The Solidarity trials are not, in fact, testing the benefits of HCQ on Covid-19, but rather are testing whether patients survive toxic, non-therapeutic doses.**

5. The conclusions to be drawn are frightening:

a) WHO and other national health agencies, universities and charities have conducted large clinical trials that **were designed so hydroxychloroquine would fail to show benefit in the treatment**

of Covid-19, perhaps to advantage much more expensive competitors and vaccines in development, which have been heavily supported by Solidarity and Recovery trial sponsors and WHO sponsors.

b) In so doing, these agencies and charities have *de facto* conspired to increase the number of deaths in these trials.

c) In so doing, they have conspired to deprive billions of people from potentially benefiting from a safe and inexpensive drug, when used properly, during a major pandemic. This might contribute to prolongation of the pandemic, massive economic losses and many increased cases and deaths.

Results

We report, however, that chloroquine has strong antiviral effects on SARS-CoV infection of primate cells. These inhibitory effects are observed when the cells are treated with the drug either before or after exposure to the virus, suggesting both prophylactic and therapeutic advantage. In addition to the well-known functions of chloroquine such as elevations of endosomal pH, the drug appears to interfere with terminal glycosylation of the cellular receptor, angiotensin-converting enzyme 2. This may negatively influence the virus-receptor binding and abrogate the infection, with further ramifications by the elevation of vesicular pH, resulting in the inhibition of infection and spread of SARS CoV at clinically admissible concentrations.

Conclusion

Chloroquine is effective in preventing the spread of SARS CoV in cell culture. Favorable inhibition of virus spread was observed when the cells were either treated with chloroquine prior to or after SARS CoV infection. In addition, the indirect immunofluorescence assay described herein represents a simple and rapid method for screening SARS-CoV antiviral compounds.

**To note: Fauci is very invested in Moderna...the company producing the Covid vaccine. The initial vaccine human trials are being reported as harmful. The testing of the vaccine is being recklessly expedited and not going through the proper testing protocols.

The sales – by CEO Stéphane Bancel, his children's trust and companies he owns – amount to about \$21 million between January 1 and June 26, including \$6 million in May.

The company's chief medical officer, Tal Zaks, has cashed out the majority of his available stock and options, netting over \$35 million since January, the filings show.
