RE: RMA Insurance Bulletin, Action4Canada Awareness

In a document dated December 10, 2021, RMA Insurance (2510 Sparrow Drive Nisku, Alberta T9E 8N5) issued a BULLETIN, in response to Action4Canada (A4C) Notices of Liability being served upon municipalities throughout Alberta. Within this said BULLETIN, RMA compares and associates A4C to "Freeman on the Land" and "Sovereign Citizens". Action4Canada puts you on Notice herein, that we are not, directly or indirectly, impliedly or inferred, in any relationship with these two organizations, nor do we share any philosophies. Action4Canada has virtually no information or knowledge of either "Freeman on the Land" or "Sovereign Citizens". The limited information we do know is that they are advocates of a type of law or activity that we do not condone, believe in, nor support in any way, and that is not supported by our Constitution, Charter of Rights and Freedoms and the Rule of Law. Their activities, philosophies are inconsistent with A4C's position that the Constitution is the supreme law of Canada and that all our rights and freedoms are absolutely protected under the Charter and Criminal Code.

Your comparisons with, and allegations against A4C are completely false and factually unsupported. In so doing, you have and continue to defame, libel and/or slander A4C and/or our Executive and/or members. Your comments tend to lower us all, individually and/or collectively, in the estimation of right-thinking members of our society generally and are completely unacceptable.

RMA also makes several libellous and defamatory accusations claiming that citizens who are serving the Notices of Liability pose a security threat and advise individuals to contact local law enforcement if they feel threatened.

To be clear, citizens serving the NOL's are at all times respectful, non-violent, peaceful and non-threatening and are exercising their right to the freedom of speech and their concerns over elected officials, in trusted positions, who are in violation of the law and individual's rights.

Action4Canada is herein demanding that you immediately cease and desist publication of any and all such comments, insinuations, comparisons, inferences, allegations, and/or other communications which in any way, directly or indirectly, impart to others the belief, allegation and/or accusation that Action4Canada and/or its Executive and/or its members, share any similarities, affiliations or associations with "Freeman on the Land" or "Sovereign Citizens" or in any way pose a threat to society. We do not.

Action4Canada is further demanding that RMA Insurance immediately retract their aforesaid publicized information and comparisons of us to "Freeman on the Land" and "Sovereign Citizens", which is knowingly false, misleading, and promoting hate against A4C, its Executive and members and notify us of same.
