Sir/Madam:

Re: Educational Administrators, Teachers, and Support Staff Freedom and Rights Notice

This Notice is to advise you that Educational Administrators, Teachers, and Support Staff will no longer comply with arbitrary Health Orders as they are unlawful, irrational, inconsistent, and in violation of the Canadian Constitution, Charter of Rights and Freedoms, and Bill of Rights, as well as the Universal Declaration of Human Rights, and the Nuremberg Code.

In addition, the Federal Emergency Act preamble states clearly that emergency orders cannot, and do not, supersede either the Canadian Charter of Rights and Freedoms or the Canadian Bill of Rights.

AND WHEREAS the Governor in Council, in taking such special temporary measures, would be subject to the Canadian Charter of Rights and Freedoms and the Canadian Bill of Rights and must have regard to the International Covenant on Civil and Political Rights, particularly with respect to those fundamental rights that are not to be limited or abridged even in a national emergency.

On April 8, 2021 ¹ a German Court ruled against masks, social distancing and testing for students. Stating, "the measures now prohibited represent a present danger to the mental, physical or psychological well-being of the child to such an extent that, if they continue to develop without intervention, considerable harm can be foreseen with a high degree of certainty." The judge further stated: "The children are physically, psychologically and pedagogically damaged and their rights are violated without any benefit for the children themselves or third parties."

Further, according to the German court's conviction, "school administrators, teachers and others cannot invoke the state-law regulations on which the measures are based, because they are unconstitutional and thus void." This would apply in Canada as well. The Canadian Health Orders are based on the claim that we are experiencing a "public health emergency" yet there is no evidence to substantiate this claim. In fact, the evidence indicates that we are experiencing a rate of infection consistent with a normal influenza season.

The ²Global Report and Summary of Facts produced by the World Doctors' Alliance in association with the Extra-parliamentary Corona Investigation Committee states that 90% of COVID-19 cases could be false positives. This substantive 73-page provides evidence-based information on the actual rate of death, PCR testing, masks, and harms of the lockdown measures.

Given that Canada's population is 37,855,621, and that 15,605 deaths in Canada are reported to be "related" to COVID-19, the percentage of Canadians who died "with" the virus is 0.041%, which indicates a 99.96% survival rate. As reported by the CDC, the vast majority of people who died due to COVID-19 were over the age of 80, and 99.2% were also suffering from two to three other serious illnesses or comorbidities.

³Studies by immunologists and doctors worldwide have found that COVID-19 is no more severe than the yearly influenza, and that the testing for coronavirus is inaccurate as it tests the serum antibody rather than looking at the T cell response.

The purported increase in “cases” is a direct consequence of increased testing through the inappropriate use of the PCR instrument to diagnose COVID-19. It has been well established that the PCR test was never designed or intended as a diagnostic tool, and is not an acceptable instrument to measure this so-called pandemic. Its inventor, Kary Mullis, has clearly indicated that the PCR testing device was never created to test for coronavirus. Mullis warns that, “the PCR Test can be used to find almost anything, in anybody. If you can amplify one single molecule, then you can find it...because that molecule is nearly in every single person.”

In light of this warning, the current PCR test utilization, set at higher amplifications, is producing up to 97% false positives. Therefore, any imposed emergency measures that are based on PCR testing are unwarranted, unscientific, and quite possibly fraudulent. An international consortium of life science scientists has detected 10 major scientific flaws at the molecular and methodological level in a ⁴[peer review of the RTPCR test to detect SARS-CoV-2. A Portuguese court has ruled that ⁵PCR tests are unreliable.](#)

Masks are proven to be ineffective in protecting against influenza and aerosol size respiratory illnesses. Children are at very low risk of contracting the respiratory virus and nearly zero percent chance of transmitting it. Further, schools are reportedly at very low risk of transmission of the virus. According to ⁶[peer reviewed studies](#), the use of masks to prevent the spread of COVID-19, is not only ineffective, but can also affect both the physical and mental fitness of the user, putting them at risk of systemic hypercapnia and/or hypoxia due to prolonged use. The study, ⁷[“Masks, False Safety and Real Dangers, Part 3: Hypoxia, Hypercapnia and Physiological Effects”](#) further reveals that mental acuity is jeopardized, which is critical to perform duties effectively resulting in risk to teachers and children.

As professionals who are responsible for the care of children, we cannot ethically or in good conscience comply with personally wearing masks, or enforcing children to wear masks. There is ample evidence to support the claim that the mask mandate Orders are putting the public at greater risk of harm. This is supported by the significant increase in calls responding to respiratory distress (chronic/acute hypoxia, asthma/COPD), mental health issues, and drug overdoses while COVID-19 related calls are, at best, minimal to none.

The Health Orders/COVID measures are harming children both physically and mentally. This is clearly demonstrated by the startling ⁸[31% increase in mental health-related hospitalizations of adolescents aged 12 to 17](#) since the onset of the pandemic, and the alarming fact that pre-teens and teens have the highest rate of suicide ideation as compared to other age groups.

⁹[The Case of the 2015 Ontario Nurses Association, addressing the Vaccinate or Mask Policy](#), provides additional evidence that masks do not work according to expert evidence submitted. The arbitrator, Kaplan, ruled that the policy was unreasonable and illogical. BC’s Health Officer, Dr. Bonnie Henry, was an expert witness in the case and was instrumental in overturning the Vaccinate or Mask mandate which also revealed that those who were asymptomatic did not spread viruses. In 2020, Bonnie Henry confirmed her position on record that masks are not effective. ¹⁰[Researchers also support Henry's statement that there is no asymptomatic or presymptomatic spread of this virus.](#)

Henry recently attempted to deceive the public ¹¹[by denying her consistently expressed position that masks are ineffective.](#) This is causing a great deal of confusion and a lack of confidence in the government’s ability to make trustworthy decisions. Coercion and manipulation without evidence-based facts is no longer sufficient.

This Notice further addresses the growing threat over job security related to vaccination. ¹²[A video message on Employee Rights and the COVID-19 Vaccine by Canada's top Constitutional lawyer, Rocco Galati](#), verifies that forced masking and vaccination are a direct violation of the civil liberties of all Canadians, the Canadian Constitution, the Canadian Charter of Rights, and the Universal Declaration on Human Rights.

In a letter dated October 3, 2020, Dr. Michael Yeadon, a former Vice President of Pfizer stated, "All vaccines against the SARS-CoV-2 virus are by definition novel. If any such vaccine is approved for use under any circumstances that are not EXPLICITLY experimental, I believe that recipients are being misled to a criminal extent."

This is evidenced in the numerous reports wherein extreme adverse events are occurring immediately following the first dose of the COVID vaccine. Teachers and administrators have reportedly been suffering severe side-effects to the extent that the vaccine has been pulled, only to be replaced by the Pfizer vaccine, which is also known to have severe side-effects, including ¹³[female sterilization and a 366% increase in the death of unborn and newborn children](#). We hold that any medical intervention requires voluntary consent. Canada is a signatory to The Universal Declaration of Bioethics and Human Rights which describes consent as "any preventive, diagnostic and therapeutic medical intervention is only to be carried out with the prior, free and informed consent of the person concerned, based on adequate information. The consent should, where appropriate, be expressed and may be withdrawn by the person concerned at any time and for any reason without disadvantage or prejudice."

According to the Nuremberg Code, developed in response to the medical abuses of the Nazi regime, informed voluntary consent means that "the person involved...should be able to exercise free power of choice, without the intervention of any element of force, fraud, deceit, duress, over-reaching, or other ulterior form of constraint or coercion." Those advocating for mandates and other coercive measures that remove the right to voluntary consent are undermining essential individual rights and freedoms. We have the legal right to refuse any unwanted medical intervention.

The Health Orders related to COVID-19 are a clear violation of the Canadian Charter of Rights (Section 2(a)(c)(d), 7, 8, 9, and 15), the Bill of Rights, the Universal Declaration of Human Rights, the Nuremberg Code, and the medical code of ethics, and are an infringement of our civil liberties.

Therefore, we cannot lawfully be compelled to comply with such orders and further, teachers and administrators have no legal authority to mandate masks.

We are putting all Provincial/Territorial Premiers and Health Officers in Canada on notice that we will no longer comply with the Orders unless evidence is provided to constitute an official emergency.

We also demand that human rights be respected. Please act accordingly.
