#### How to Serve the Notice of Liability

- Print two copies of the Notice of Liability.
- Fill in the name of the person being served in the space provided at the top of the first page - on both copies.
- Sign your name and fill in the date in the space provided on the last page - on both copies.
- Keep one copy of the Notice for your records.
- Give the second copy to the person you are serving it to. If they choose not to accept it, then leave it on the floor at their feet.
- If you are serving the Notice in person, be sure to video record yourself serving it (or audio record if video is not possible).
- **If sending by mail, you must use registered mail as that provides proof of delivery.**

Keep all information (eg. Liability Notice copy, video, mailing proof etc.) in a safe place for future use.

**NOTE: You do not need a lawyer to serve a Notice of Liability and you do not need consent, or the signature of the person you are serving it to.**

## **Notice of Liability COVID Non-Consent for Minors – Parent/Legal Guardian Including, but not Limited to Masks, Sanitizers, Social Distancing, and “Vaccination”**

To: Anyone involved in any education or activities related to minors (School Superintendent, School Board Executives, School Principal, Teacher, Administration, Bus Drivers and Union, Coach/Instructor etc)

This is to notify you that I (including my child) will no longer comply with any mask guidelines and/or other COVID mandates in the public/private school system. The COVID measures are unauthorized by law and are in violation of the Charter of Rights, Bill of Rights, and the Convention on the Rights of the Child. The mandates are putting children at risk of harm both physically and mentally.

Medical mandates are guidelines not laws. For instance, there is no law in Canada whereby masks are legislated because Canadians have the 100% right to breathe freely, protected under the Charter of Rights, Human Rights as well as International Agreements.

On April 8, 2021 a German Court ruled against masks, social distancing, and testing for students. Stating, *“the measures now prohibited, represent a present danger to the mental, physical or psychological well-being of the child to such an extent that, if they continue to develop without intervention, considerable harm can be foreseen with a high degree of certainty. The children are physically, psychologically, and pedagogically damaged and their rights are violated without any benefit for the children themselves or third parties.”*

Further, according to the German court's conviction, *“school administrators, teachers and others cannot invoke the state-law regulations on which the measures are based, because they are unconstitutional and thus void.”*

Masks are ineffective in protecting against influenza and other aerosol-sized respiratory illnesses. BC Health Officer, Bonnie Henry, attested to this in the 2015 Ontario Nurses Arbitration saying, *“there’s very scant evidence about the value of masks in preventing the transmission of influenza.”*

Common side-effects of mask wearing include headaches, drowsiness, dizziness, reduced ability to concentrate, and reductions in cognitive function. Also, given that the development of neurodegenerative diseases can take years to manifest, we cannot ignore the potential long-term harms of continual mask usage. The stressful impact of masking also runs the risk of having a damaging and permanent impact on our child’s immune system.

Additional medical harms caused by masks and hand sanitizers include rash and burning skin irritations.

There is a staggering 24-31% increase in emergency mental health hospitalizations and an alarming increase in suicide and suicide ideation in minors as a result of the harmful COVID measures.

Minors are at nearly zero percent risk of contracting or transmitting this respiratory illness and are, instead, buffers which help others build their immune system. The overall survival rate of minors is 99.997%. Further, schools are reportedly at very low risk for transmission of this virus.

In response to lobbying from the Teacher's Unions and other NGO groups, the Government and Health Officers are ignoring the harms to children and are instead continuing to implement the exaggerated emergency measures.

Therefore, as parent/legal guardian, in the best interest of my child, I hereby serve you with this official Notice of Liability excluding my child from any and all restrictions, mandates, and/or medical treatments which are, or may, cause physical and psychological harm, interfere with my child's guaranteed right to an education and/or participating in any extra-curricular activities. Should you not immediately comply, I will hold you culpable for any harm or injury to my child that may result from your actions, or lack thereof. I expect that my child will not be segregated or discriminated against and will be treated with the utmost respect and fairness in regards to this matter.
