How to Serve the Notice of Liability

- Print two copies of the Notice of Liability.
- Fill in the name of the person being served in the space provided at the top of the first page - on both copies.
- Sign your name and fill in the date in the space provided on the last page - on both copies.
- Keep one copy of the Notice for your records.
- Give the second copy to the person you are serving it to. If they choose not to accept it, then leave it on the floor at their feet.
- If you are serving the Notice in person, be sure to video record yourself serving it (or audio record if video is not possible).
- **If sending by mail, you must use registered mail as that provides proof of delivery.**

Keep all information (eg. Liability Notice copy, video, mailing proof etc.) in a safe place for future use.

NOTE: You do not need a lawyer to serve a Notice of Liability and you do not need consent, or the signature of the person you are serving it to.

RE: WEF SMART Cities/15 Minute Cities/C40 Cities

This letter is in response to the United Nation (UN)/World Economic Forum's (WEF)/ICLEI (Local Governments for Sustainability) Canada's¹ agenda to coerce member states into implementing SMART Cities/15 Minute Cities/C40²/Resilient Cities under the guise of the Sustainable Development Goal/environmental initiative SDG 11³, to reduce city costs, meet the needs of citizens within a 15 minute radius, and promote health and equity⁴.

The WEF/UN Agenda is to strategically and incrementally levy the takeover of each nation, using the Global Compact on Migration and the 17 Sustainable Goals as a front, in order to achieve a Global Government. The Environmental, Social and Governance (ESG) campaign and the Paris Climate Agreement are also key factors in gaining control.

The purported justification for 15 Minute Cities is to fight climate change, save the planet and humanity. However, 15 Minute Cities will have little to no effect on the climate and instead will destroy the economy, isolate citizens, and restrict mobility. The cost of implementing 15 Minute Cities is in the billions of dollars per city and the hypothetical benefits being lauded by "experts" do not take into consideration the resulting negative consequences. In addition, devastation is being caused to many major economies of the world through the unnecessary mandates for drastic reductions in the use of fossil fuels.

Despite the hyperbole being utilized to obtain mass formation and compliance, the 'science' does not support climate change. Tom Moser, retired NASA, and founder of TRCS⁵ which consists of a team of scientists and engineers who provide scientific and empirical data to counter the misinformation being provided by 0.3% of scientists who claim humans are causing climate change, states the following:

- Human produced carbon dioxide is not causing the climate to change.
- The global temperatures and CO2 levels have been changing between extremes since the beginning of time.
- 0.3% scientists (not 97%) believe humans are causing climate change.
- The amount of human produced CO2 in the atmosphere is negligible.
- Increased CO2 is not causing weather extremes.
- CO2 is safe, good and not a pollutant (in fact it has resulted in a significant greening of the planet⁶)
- "Human produced CO2 is causing climate change" is a political agenda.

Dr. William A. van Wijngaarden of the Department of Physics and Astronomy, York University, Canada, and Dr. William Happer of the Department of Physics, Princeton University, have stated that at current concentrations, carbon dioxide and other greenhouse gases are having very little effect on temperatures⁷.

Elected officials are being heavily lobbied by global entities and coerced and financially incentivised to implement a global agenda but they are being misinformed. The reality is that SMART Cities/15 Minute Cities/C40/Resilient Cities are an incremental but significant step towards implementing a social credit system and a police state that knows everything about everybody: what you eat and drink; where you go; what you buy; who you meet; what you think; how you feel; your opinions; your habits; your health and vaccination status. The WEF⁸ is pushing this agenda, using Covid 19 mandates and climate alarmism as a catalyst.

The WEF has already made statements that a climate emergency could result in further lockdowns⁹ and the 15 Minute Cities will give the government the ability to completely restrict mobility. The Covid 19 lockdowns were responsible for widespread social and economic devastation and considered the most catastrophic health policy mistake of all human history¹⁰.

The mass surveillance and biometric technology, that is a significant part of the 15 Minute City scheme, violates the privacy rights of citizens by tracking their every move using harmful, military-style technology. It is being implemented¹¹ as part of the Digital ID tracking system.

A newly released report by the Canadian Security Intelligence Service¹² warns that SMART Cities pose security risks due to the surveillance technology and urges policymakers, and the technology industry, to consider steps that can be taken to address and ease that emerging security threat before "smart city" platforms are widely adopted.

"Smart city devices collect massive amounts of personal data, including biometric data and other information highlighting personal life choices and patterns. Hostile state actors are currently exploring various means of attaining access to future smart city platforms, including through access provided by state-owned or state-linked technology companies."

It has already been well documented¹³ that Canada is under significant threat from foreign interference, to the level that in 2019 the National Security and Intelligence Committee of Parliamentarians reported¹⁴ that our Charter of Rights and Freedoms, and Sovereignty are at risk. The federal government has intentionally aligned with the WEF and the UN and are fully aware that by doing this they have created a significant security breach, which is putting Canadians at risk and violating their individual rights.

SMART Cities/15 Minute Cities/C40/Resilient Cities are a subversive attack on our democracy which unlawfully and fraudulently has the potential to empower all levels of government, whilst simultaneously violating the God-given freedoms and Constitutional rights of citizens.

It is alarming that mayors¹⁵ are aligning with the WEF's fraudulent environmental initiative. Be advised that this is an exercise in futility as it is in direct violation of citizens' guaranteed rights according to the Constitution, the Charter of Rights and Freedoms, the Coronation Oath and the Criminal Code. You cannot restrict Canadians' mobility, interfere with their privacy or with their right to "Life, Liberty and Security" of the person. This is a blatant act of government overreach in alignment with an aggressive foreign power.

The UN and WEF are unelected bodies and therefore, have no authority to tell Canadians what to do. Section 52(1) of the Constitution Act, 1982: The Constitution of Canada is the supreme law of Canada, and any law that is inconsistent with the provisions of the Constitution is, to the extent of the inconsistency, of no force or effect.

Charter of Rights and Freedoms

Charter – Section 6 – Mobility Rights Provision

- (1) Every citizen of Canada has the right to enter, remain in and leave Canada.
- (2) Every citizen of Canada and every person who has the status of a permanent resident of Canada has the right:
 - a) to move to and take up residence in any province; and
 - b) to pursue the gaining of a livelihood in any province.

Guaranteed Right to not be Prohibited, Harassed or Detained in Doing So

Charter – Section 7 – Legal Rights

Everyone has the right to life, liberty, and security of the person and the right to not be deprived thereof except in accordance with the principles of fundamental justice.

Charter – Section 8

Everyone has the right to be secure against unreasonable search and seizure.

Section 8 also covers the right to personal and medical privacy.

The values underlying the privacy interest protected by Section 8 are dignity, integrity and autonomy (R. v. Plant, [1993] 3 S.C.R. 281 at page 292). The protection Section 8 provides for privacy — personal, territorial and informational — is essential not only to human dignity, but also to the functioning of our democratic society.
