## Re: Unlawful masking of children

It has come to my attention that the government is advising, possibly mandating, that children once again wear masks. There is absolutely no medical evidence to support this decision. In fact, masking children has proven to cause severe emotional and psychological trauma, respiratory distress, and hinders their social/emotional development due to the lack of facial communication exposure.

Masks are not legislated in Canada. It is not law and cannot be made law because it is in violation of a citizen's right to breathe freely. Masks have been proven useless in protecting against the spread of aerosol-sized respiratory illnesses and therefore wearing them only gives people a false sense of security. They have never before been used on children in response to the yearly cold and flu (RSV) season and they are not required now.

BC Health Officer, Bonnie Henry, has repeatedly stated that masks are ineffective<sup>1</sup> in preventing the spread of viruses:

- In 2015 she appeared as an expert witness, sworn before a statutorily authorized arbitrator in the Ontario nurse's arbitration, to provide evidence on the ineffectiveness of masks. The arbitrator in that case ruled that masks were punitive, discriminatory and meant to push vaccination, and stated that Dr Henry's evidence was a decisive factor in reaching his conclusion<sup>2</sup>.
- On December 4, 2019 Bonnie Henry signed an agreement in support of BC nurses, based on the Ontario arbitrator's decision, that again confirmed that forcing nurses to wear masks was punitive and discriminatory.

Forcing children to wear masks is cruel and abusive.

The government, both provincially and federally, have admitted that lockdowns and covid measures were based on little knowledge of the virus, models and predictions. It is time to put an end to this harmful agenda.

You have **no** medical or legal authority to mask our children and you are not immune from liability should you do so. I am serving you with the attached personal Notice of Liability (NOL) to give you the opportunity to do the right thing and cease and desist, due to the harm it is causing. Should you choose to not comply, this NOL may be used as evidence against you in future actions.

I trust you will make the right decision.
